LHS training provides oversight in developing effective Occupational Health & Safety Management Systems (OHSMS). It covers the key elements of a comprehensive program, as follows:

Training is designed to assist participants in developing and maintaining an OHSMS for their workplace. Participants learn effective techniques to fulfill their health & safety responsibilities, and keeping health and safety in balance with production, quality and the environment. Each participant receives a student manual for class involvement and future reference. An action plan accompanies each element to guide implementation in their workplace. By completing each element, participants develop a comprehensive action plan to take back, research, confirm, and implement in their workplace. **LHS is a pre-requisite for Auditor training.

Health and Safety Auditor Training is a two-day course designed to assist prospective health and safety auditors in developing the necessary skills to successfully complete a qualification audit and achieve AFPA Health and Safety Auditor certification. It is also designed for small employers intending to assess their own companies for SECOR certification. Auditor training covers:

Auditing fundamentals	Documentation review, interviews and observation tour completion
A breakdown of the audit process	Audit report write-up 'how to'

After successful course completion, auditor/assessor candidates must submit a qualification audit or SECOR assessment, that meets the established AFPA quality standard, within six (6) months.

Applying Risk Based Thinking using an X/Y risk matrix

Effective Hazard Control through hierarchy and immediate vs. long-term measures

The Incident Investigation training equips participants with effective techniques for investigating incidents. Covering the entire process, from evidence gathering to recommending corrective actions, the course emphasizes:

Steps in an investigation, including evidence collection and cause analysis

Encouraging incident reporting and ensuring remedial actions

Writing investigation reports and follow-through for effective outcomes

Participants will learn successful investigation methods applicable to their own work scenarios. The course, available as either a 1-Day or 2-Day session, offers customizable training. The 1-Day session focuses on fundamentals with a case study, while the 2-Day session delves deeper into case studies through practical exercises for a comprehensive understanding. Both sessions are led by top-notch instructors known for their expertise in occupational health and safety, ensuring quality training.

To maintain certification, Health & Safety Auditors and SECOR Assessors are required to refresh their training at least once every 3 years. SECOR Assessors may have other refresher options – contact AFPA for details.

Training includes an overview of any changes to the auditing process and/or legislation, a review of maintenance options available to qualified employers and an analysis of auditing issues identified through AFPA's quality assurance process. This is also an opportunity for auditors/assessors to voice any concerns not previously discussed.

FUNDING OPPORTUNITIES

CANADA-ALBERTA JOB GRANT

Eligible employers can get government funding to help employees and unemployed Albertans access training opportunities.

The Canada-Alberta Job Grant is a training program where an employer applies on behalf of their present or future employees for eligible training costs. Employers decide who gets training and what type of training may be needed for their employees.
